**WOODSTOCK INN & RESORT CONTRACT AND EXPRESS ASSUMPTION OF RISK FOR RESORT ACTIVITIES**

**INHERENT RISK:** I understand my participation in the activities and use of Woodstock Country Club, the Activity Center, Saskadena Six Ski Area and Woodstock Athletic Club including but not limited to the Ski and Ride School, golf, mountain biking, alpine skiing and/or snowboarding, nordic skiing, mountain biking and rentals, fishing and guided fishing, tennis, fitness classes and all other activities offered by Woodstock Inn & Resort, Woodstock Country Club, Woodstock Athletic Club, the Activity Center and the Saskadena Six Ski Area (all collectively "Activities" or singularly "Activity"), involve inherent and non-inherent risks which may result in **PROPERTY DAMAGE, INJURY AND/OR DEATH**, these risks including, but are not limited to: falling; slick or uneven surfaces, including walking surfaces; surface and subsurface conditions; moguls, jumps and natural and manmade terrain features; ice; snow and ice conditions including variations in terrain; golf cart use and mechanical issues, sprinklers and irrigation systems, maintained and unmaintained trails, bridges, and paths, variable golf course and mountain bike trail conditions, design, construction and condition of man-made or natural features; forest growth or trees, stumps, tree wells, downed trees, logs, limbs or branches on or off trail; rocks and debris; marked and unmarked obstacles, hazards, and equipment; bare spots; collisions or impacts with other people or objects, including snow making equipment, snowmobiles, snowcats, hikers and walkers, ATVs, mountain bikers, or other vehicles and manmade and/or natural features and hazards; trail intersections; competition venues; the decision-making, conduct and instruction of the ski area personnel such as instructors and patrol; the malfunction, misuse, or failure of equipment such as golf carts, bicycles, skiing and snowboarding equipment, or any other product or piece of equipment to perform as intended or represented; lift or other conveyance loading, unloading, and riding; and changing and adverse weather and surface conditions; variations in surface conditions; changing water conditions; and surface conditions on any court, course, trail, walkway, path, or other surface offered for guest use. Despite these risks and any and all other risks inherent to the Activities, **TO THE FULLEST EXTENT ALLOWED BY LAW, I AGREE TO EXPRESSLY ASSUME ALL RISKS OF PROPERTY DAMAGE, INJURY OR DEATH** that might be associated with, arise from or be obvious and necessary to my participation in such Activities and use of Woodstock Country Club, the Activity Center, Saskadena Six Ski Area and Woodstock Athletic Club. **I agree** that I am responsible for having the physical ability and knowledge to load, ride, and unload lifts. **I agree** that I am always in control of my speed and course. **I agree** to abide by all applicable laws, ordinances, codes, and Your Responsibility Code while participating in the Activities. Summer Activities and attractions present their own special risks. I acknowledge that I can elect not to ride or participate in an activity whenever I choose. I agree to always proceed carefully and courteously and walk my bike whenever conditions warrant. **WHEN IN DOUBT, WALK!**

**ASSUMPTION OF RISK, RELEASE OF LIABILITY AND COVENANT NOT TO SUE:** To the fullest extent allowed by law, I hereby **COVENANT NOT TO SUE and RELEASE** The Woodstock Resort Corporation dba Saskadena Six Ski Area, Woodstock Country Club, Woodstock Athletic Club or the Woodstock Inn & Resort, and their agents, owners, employees, volunteers, directors, officers and shareholders and affiliated companies, including the Ski and Ride School ("Released Parties"), **from ANY AND ALL RESPONSIBILITY OR LEGAL LIABILITY** for any and all claims asserted by anyone arising out of any injuries, damages or death I may suffer, whether caused by **NEGLIGENCE** or any other cause, related to my participation in any Activity. I further agree that neither I nor my estate, heirs or assigns **WILL EVER SUE** the Released Parties, and that **I AGREE TO INDEMNIFY AND HOLD HARMLESS** the Released Parties if any claim or action is pursued by anyone arising out of any injuries, damages or death to me that has any connection whatsoever to any Activity.

**THIS IS A CONTRACT** which provides a **COMPREHENSIVE RELEASE OF LIABILITY** to the greatest extent allowed by law, but it is not intended to create or permit any claims or defenses that are prohibited by law. If any portion of this document is deemed unenforceable, all other portions shall be given full force and effect. **ALL CLAIMS** arising from any activities I participate in at Woodstock Country Club, the Activity Center, Saskadena Six Ski Area and Woodstock Athletic Club including those claims related to **PROPERTY DAMAGE, INJURY and/or DEATH**, shall be governed by the law of Vermont and I agree and understand that the exclusive jurisdiction for any claim or lawsuit I may bring related in any way to this Agreement or any Activity shall be brought only in the state or federal court of Windsor County, Vermont. I further agree that even if for any reason this Agreement or any part of it shall be deemed prohibited by law, this Agreement can be used as evidence and an exhibit in any legal matter pertaining to its terms, my acceptance of inherent risks with any Activity and/or my agreement to all obligations set forth herein.

**MINORS:** As a parent/guardian with legal responsibility for the minor named below, I represent that I am authorized to accept this Agreement for the minor child. I consent and agree that I, for myself, and for the said minor child are bound by this Agreement AND I hereby agree to defend, hold harmless and indemnify the Released Parties for any and all claims, costs, legal fees or expenses of any kind arising out of the child's participation in any Activity resulting from any alleged act or omission by any Released Party in the operation, maintenance or design of the property or Activity, or any other conditions on any Released Party's premises, my obligation to defend and indemnify to include all attorney fees and costs incurred by any Released Party in enforcing this requirement to defend and indemnify and the terms of this Agreement.

I have read and acknowledge this agreement, and I am signing it of my own free will.
